Tracking Tax-Deductible Expenses

While business owners should not routinely use QuickBooks to track personal expenses, an owner may on occasion write a business check for a personal expense. Since some expenses are tax-deductible on the owner's personal 1040 Schedule A tax return, owners may need to run a QuickBooks report to verify amounts for tax forms.
